

## 米顿坚斯中文学校及社区中心

## 2026-2027学年中文学校招生章程

本机构宗旨：本机构为一无宗教，无政治色彩的非营利志愿团体，任何人仕无关宗教、种族、国籍均可申请成为会员。本机构旨在提供中文教学，弘扬中华文化。为了更好的服务本地社区，本会不定期举办文娱活动：如农历新年庆祝会。

1. 报名资格：在2026年9月1日时年满五岁，有兴趣修读本校课程之人仕。学生需要有自行如厕的能力。
2. 所有新生必须在报名时出示出生日期证明。报名者必须是新生之直系亲属。如果需要代表新生之直系亲属报名，必须预先向本校申请，而且有委托书证明身份。如果理由充足的话，本校将会通知受托人可否为新生报名。本校广东话班学生若要转为普通话班(或者从普通话班转为广东话班)者，报名程序和新生一样。
3. 上课日期：由2026年9月13日至2027年7月4日之周日（除本校假期外）。详情请参考学校日历，链接如下：

4. 上课时间：星期日 9:30AM-11:30AM（课间休息十分钟）。
5. 上课地点及校务处：St. Paul's Catholic School, Phoenix Drive, Leadenhall, Milton Keynes MK6 5EN（校务处只在上课日开放，工作时间同上课时间。）
6. 在线教学：由于非本校可控的社会性事件的影响，或其它特殊情况，学校将视具体情况，临时改为线上教学。

8. 报名时间：
  - 1) 学校统一报名注册时间为2026年6月7日至2026年7月5日。于2026年7月6日及之后报名者，则须另缴付£30管理费。
  - 2) 报名采取先到先得的方法，请收到位置确认的家长，于邮件中指定日期前提交所需的表格文件及完成缴费。
9. 班级设置及教材：（在有需要时，本校有权取消或更改任何班级。）

10. 校服：
  - 1) 为了便于学生的安全管理，学生（成人班除外）必须穿着本校校服上课。有需要者请于报名时订购校服。
  - 2) 成人班学生若选择不穿校服，则必须佩戴校牌。（学校将提供校牌）
11. 报名及缴费方法：请填写学校网站上公布的报名表，并按提示上传所需文件及缴费证明。
12. 插班：
  - 1) 学校在相应班级有位置的情况下，满足相应条件可接受插班申请。
  - 2) 普通话班一年级，只在学年的第一个学期内接受插班申请。
  - 3) 插班普通话二年级至十年级，以及广东话中级班或高级班，必须参加入学编班测试。
  - 4) 插班学费按学期计算，不满一学期按一学期计算，另有行政管理费及插班考试费（若适用）。
13. 校规：学生若触犯校规而屡劝不改，校方有权勒令其停学，甚至开除学籍。

14. 学校不接受任何形式的，对学校老师及工作人员的欺辱霸凌。一旦有此情况发生，学校保留开除学生学籍的权利。
15. 会员及会员权利：在学生报名表上登记的学生将成为本会的学生会员。如这学生未年满十八岁，该学生的其一家长或监护人(在学生报名表上签署者)将成为本会的家长会员。
  - 凡十八岁或以上的学生会员和家长会员都拥有在本会的周年或特别大会的投票权。
  - 会员可参加学校组织的额外活动，如课外兴趣班等。（若是非本校学生欲参与此类活动，则需加付会员费）
  - 各会员须遵守学校规章制度。
16. 中途退学：学生如欲申请退学，本校必须于一个学期前收到家长/监护人之退学通知才可生效，学校可在扣除管理费后退还学费余数。若学生因违反校规而遭校方开除者，学费恕不退还。

## School Enrolment Information for 2026/2027 academic year

Milton Keynes Chinese School & Community Centre (MKCSCC) is a non-religious, non-political voluntary organisation running on a “not for profit” basis for the benefit of the local community. Membership is open to all persons regardless of race, religion or nationality. Our main objectives are to advance education in Chinese language, culture, heritage and arts as well as to provide facilities for recreation and other leisure activities.

1. Minimum age requirement: New students must be at least 5 years old on 1st September 2026 and must have been toilet trained.
2. All new students must produce proof of “Date of Birth” at the point of enrolment. Applicants must be parents/guardians of the new student(s). If a representative is necessary, this must be applied to the school in advance together with a letter of authorisation to prove the identity. If the reasons are acceptable, the school will inform the representative to enrol. Any existing students wishing to switch from Cantonese to Mandarin classes, or vice versa, will be considered as new students for enrolment.
3. School Dates: Sundays from 13th September 2026 to 4th July 2027 inclusive (except school holidays), please refer to the school calendar for details:

4. School hours: Sundays 09:30am to 11:30am
5. School venue: St. Paul's Catholic School, Phoenix Drive, Leadenhall, Milton Keynes MK6 5EN (the school office only opens on days with lessons)
6. Online teaching: There may be unforeseen circumstances when it would be necessary to host online lessons temporarily.
7. Fees: To support the school running, the fees are mainly constituted by membership fee and tuition fee, detail as follows:

8. Enrolment time window and the classes settings:
  - 1) The standard enrolment window is **7th June 2026 - 5th July 2026**. Enrolment from 6th July 2026 and thereafter will incur additional £30 admin fee.
  - 2) Due to limited class spaces, the enrolment runs on a first come first serve basis. Parents who receive the confirmation of a school space, must follow the instructions in the email to provide the related forms and documents if applicable, as well as paying full fees before the given date.

9. Classes and the textbooks: (The school reserves the right to cancel classes at any time or make alternative arrangements)

10. School Uniform: For better safeguarding, the wearing of our school uniform (sweatshirt or polo shirt) is compulsory. Adult students can opt to wear a school badge (the badge will be provided by the school) instead of a uniform. Please place the uniform order at the same time as enrolment if required.
11. Enrolment: Please follow the enrolment instructions published on the school website and provide the required documents and payment proof.
12. Halfway join:
- 1) If space allows and other criteria met, the school accepts the halfway joining application.
  - 2) For Mandarin class year 1, the halfway join application will be only accepted during the first term of the academic year.
  - 3) An entry test is required if you intend to join year 2-10 of Mandarin Class / Cantonese Intermediate class / Cantonese Advance class directly. Test fee applicable.
  - 4) The fees are calculated per term. If less than a term, it will be calculated as a term. Administration fee applicable. Test fee applicable if entry test required.
13. Students who persistently violate the School Rules & Regulations may be suspended or expelled.
14. The school will not tolerate any form of insulting or bullying behaviour towards teachers or school staff. If such things happen, the school reserves the right to expel the student.
15. Membership and the rights: The student will become a student member of the organisation. If the student is under 18 years old, the named parent/guardian who signs the declaration on the enrolment form will become a parent member.
- o Any parent member or student member who is 18 or over shall have a single vote at the annual/extraordinary general meeting.
  - o Membership will allow the student to join other events/activities that the school organises outside of school hours. If non-school members wish to join these activities, they would need to pay the membership fee in addition to any event/activity fees.
  - o All members must follow the school policies.
16. Withdrawal: If you wish to leave the school, please give one clear full term's written notice to the school. You will then be entitled to a refund of the unused portion of the fees you have paid less an admin fee.
17. On the enrolment form, the school would need you to provide consent to:
- 1) Whether photographs or videos of you or your child taken during school hours, community events or outings, can be used in our internal publications.
  - 2) All correspondences from MKCSCC will be sent via email. It is your responsibility to ensure that the email address you provide to us is current and valid such that notifications and correspondences are received.
